Environmental Management System on the Urban Beaches of Roses

ENVIRONMENTAL POLICY FOR ALL URBAN BEACHES, NATURAL COVES AND PROMENADE IN THE MUNICIPALITY OF ROSES

The ROSES CITY COUNCIL is aware of the importance of protecting the Environment, of preserving Natural Resources and the main space of the town's life: the beaches and natural coves.

Therefore, with the aim of carrying out its activity in a way that respects the environment, it undertakes to implement and improve the Environmental Management System (based on the UNE-EN ISO 14001 standard and EMAS Regulation) on all urban beaches, on natural coves located in the Cap de Creus Natural Park and the Roses Promenade.

The commitment of the CITY COUNCIL of ROSES in terms of the management of its beaches, coves and promenade, is specified in the following action principles:

- Ensure compliance with regulatory environmental requirements and other specific commitments that the City Council considers, applicable at all times.
- Provide the Environmental Management System with the necessary resources to ensure continuous improvement of environmental actions, based on:
 - Protecting, within our possibilities, the environment and the coastal environment.
 - Minimising and correctly manage generated waste on beaches and natural coves.
 - Promoting the rational use of drinking water in all activities carried out on beaches and in natural coves.
 - Promoting energy efficiency in municipal facilities and equipments.
 - Reducing the environmental impacts derived from wastewater.
 - Offering environmental friendly services.
 - Preventing pollution.
- Establish appropriate training, awareness and information plans to ensure that City Hall employees, as well as relevant subcontractors, are involved, informed, understand the organisation's policy, objectives and obligations.

In order to carry out these commitments, the principles of action and practices of the Environmental Management System will be applied to beaches, natural coves and promenades. Measurable environmental objectives will be established annually, reviewed and updated by the competent Management.

This Environmental Policy will apply to all activities, seasonal concessions, products and services of all urban beaches and natural coves (Santa Margarida, Salatar, Rastrell and La Nova with the promenade adjacent to these beaches, the urban beaches of La Punta, Palangrers, Canyelles-Bonifaci and l'Almadrava, and the natural coves of Murtra, Rustella, Montjoi-Calís, Calitjàs, Pelosa, Canadell, and Jòncols) in usual, occasional and emergency situations.

The Environmental Policy and the annual Environmental Statement will be disseminated to the interested agents by the most appropriate means in each case.
